

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to embl.net and East Metro Baseball League and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to East Metro Baseball League include embl.net and EMBL. The EMBL website is a Sports & Recreation site. By using the EMBL website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, EMBL may collect personally identifiable information, such as your:

- First and Last Name
- Birth Dates

EMBL may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. All such third parties are prohibited from using your personal information except to provide these services to EMBL, and they are required to maintain the confidentiality of your information.

EMBL may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on EMBL or the site; (b) protect and defend the rights or property of EMBL; and/or (c) act under exigent circumstances to protect the personal safety of users of EMBL, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by EMBL. - SSL Protocol
